PROCULTHER is co-funded by the Directorate-General for European Civil Protection and Humanitarian Aid Operations of the European Commission (DG ECHO) and implemented by a **Consortium** led by the Italian Civil Protection Department (**Italy**). and composed of the Ministère de l'Intérieur - Direction Générale de la Sécurité Civile et de la Gestion des Crises (France), the Ministry of Culture and Tourism of the Regional Government of Castilla y León (Spain), the Ministry of Interior-Disaster and Emergency Management Authority - AFAD (Turkey), the International Centre for the Study of the Preservation and Restoration of Cultural Property (ICCROM) and the Fondazione Hallgarten - Franchetti Centro Studi Villa Montesca. PROCULTHER Consortium is also counting on the expertise from UNESCO Regional Bureau for Science and Culture in Europe.

PROCULTHER aims at **contributing to develop** the Union Civil Protection Mechanism (UCPM) and Participating States capacities to protect cultural heritage assets at risk of disaster by placing their protection at the top of national European agendas and making the enhancement of their resilience a multi-sectoral and multi-stakeholder goal. The project has been running since January 2019 and due to the pandemic crisis, its duration has been prolonged until December 2021.

PROCULTHER brings the Union Civil Protection Mechanism to the G20 Culture Ministerial Further steps to increase the resilience of cultural heritage at risk of disaster

On 12 April 2021, PROCULTHER was thrilled to participate in the G20 Culture Webinar "Addressing the climate crisis through culture" in the Session II dedicated to "Strategies and Actions for Increased Resilience of Cultural Heritage".

Project Director, Mr De Siervo, presented **PROCULTHER** as a case study, and seized this outstanding opportunity to call for the development of a common European methodology, tools, and capacities to include the protection of cultural heritage in disaster risk management processes and to ensure a structured collaboration among Cultural heritage and Civil **protection actors** at local, national, and European level.

PROCULTHER's approach and methodology in the framework of the Zagreb Conference "Solidarity in culture: Heritage protection under conditions of crisis"



The National and University Library in Zagreb organized the International Virtual Conference "Solidarity in culture: Heritage protection under conditions of crisis", a three-day event held from 18 to 20 March 2021, in partnership with the European Commission, with the support of the Croatian Ministry of Culture and Media and the National UNESCO Commission. This event is part of a process carried out in the last years by several countries, including Croatia, aimed at reducing the vulnerabilities of the cultural sector in a holistic, inter-disciplinary and integrated manner. This process is generated by a common way of thinking among the international community of experts and practitioners with regard to the synergistic and mutual benefits of solidarity networks set up by cultural institutions, that yield the most effective and immediate results in prevention, response, and recovery efforts to safeguard cultural

heritage, in **support** of the **existing general emergency services**.

When a disaster strikes, emergency responders are the first to intervene to save lives and secure the affected areas, but in the last years, due to the extensive loss of cultural heritage during the early stages of a crisis, cultural heritage experts and emergency responders have been promoting the **integration** of **cultural heritage protection** in the **disaster** risk **management cycle**. In parallel, the use of technical terms such as **resilience**, **prevention**, **preparedness**, **recovery**, **standard operating procedures**, and **pooling** of **expertise** at all levels has become increasingly **common** by both cultural heritage and civil protection experts. This trend proves that continuous **efforts** are being made to **facilitate both the**

Reflections on the Notre-Dame de Paris fire: The Cultural Heritage Protection Plan put to the test

In 2017, France had more than 45,000 protected historical monuments. In the event of disaster, civil security forces are called to intervene to protect threatened property in accordance with the **law on the modernisation of civil security of 13 August 2004**. Therefore, on the night of 15 to 16 April 2019, during the fire that ravaged Notre-Dame Cathedral in Paris, all public players mobilised to help manage the disaster and save this emblematic monument. The **Paris Fire Brigade** (*Brigade des Sapeurs- Pompiers de Paris -* **BSPP**), ordinarily engaged in the rescue of people, played an essential role in this intervention that involved also the Departmental Fire and Rescue Services (**SDIS**) of the Yvelines and Seine-et-Marne as well as the Operational Centre for Inter-ministerial Crisis Management (*Centre Opérationnel de Gestion Interministérielle des Crises -* **COGIC**), the police forces and

representatives of civil society (such as specialists in the safeguarding of cultural property). The **interoperability of the State's services** concerned by cultural heritage protection, made possible by interdisciplinary training programs and shared intervention methods, was a **determining factor** for the management of the crisis. These conditions helped facilitate the arrival of emergency services, the implementation of assessments, the coordinated scaling-up of conventional and specialised resources, the anticipation of handover, the reinforcement of the command cell and the planning of the different phases of this operation.

The genesis and sequence of events

On **15 April 2019**, at around **18h45**, the emergency services were alerted for a fire that broke out beneath the roof of the Notre-Dame Cathedral spire. The **BSPP** was organised around The BSPP's **tight operational network** enabling the deployment of a large number of human and material resources within the first half hour: finally, a total of **600 Paris firefighters** (400 in direct combat and 200 with logistical or command functions) were mobilised during this intervention. 
WHAT WE MIGHT HAVE LOST ... Fire at the Santa Marina de Balboa Church, León (Spain)

The accident

It was 3 minutes past 8 in the morning of Tuesday, last **May 4**th, when we received a call from Olivier Bao, Chief of the Ponferrada Fire Brigade, informing us of an already extinguished fire that had broken out in the early hours of the morning inside a church declared *Bien de Interés Cultural* - BIC (Site of Cultural Interest)¹ in Balboa, a small village in León (Spain), 43 km from Ponferrada (the largest town and where the municipality's central emergency service that serves other smaller towns, such as Balboa is based). All the necessary data and information were quickly gathered, that is: the movable assets involved, the extinguishing procedure implemented, the evacuated elements, etc.

The Unit for Risk Management and Emergencies in Cultural Heritage - UGRECYL was activated and deployed to the site given the impact of the accident and the fact that one of the most important cultural heritage sites of the area was affected, i.e., the main altarpiece - an important Renaissance piece².



Upon arrival at the disaster premises, with the interior covered in soot, we realized that the situation was actually better than we had expected; more than 90% of the altarpiece - only the edge of two reliefs and secondary elements

forming part of the architecture were affected³ - was saved thanks to the excellent job of the firefighters.

In order to extinguish the fire in the altarpiece and avoid affecting neighbouring areas, the firefighters focused exclusively on the source of the flames, using very little water in this process; thanks to pressure control they were able to spray it as much as possible, avoiding an uncontrolled jet of water.
